Briefly describe the program proposal (new or change) and provide a justification:

We are proposing changes to the name of the minor as well as a reduction in the number of units. We are proposing a name change to better reflect the management content. We are also proposing a reduction in units from 18 to 15 (for consistency, the department's other minors are also 15 units). The reduction in units is achieved by reducing the number of electives from 15 units to 12 units. We also reduced the number of choices of required courses from 4 to 1.

The Minor in Recreation Administration originally covered all areas of the department. Due to EO 1071, RPTA now has three separate bachelor's degrees. New minors in Park Management and Hospitality and Tourism Management are being created, and the existing minors in Non-Profit Management and Recreation Management are being edited to create a more specific focus.

Program Description

The Minor in Recreation Management is designed for non-RPTA majors interested in learning about career areas within the recreation field. This broad set of industries can lead to careers in experiential education, community sports (for youths, teens, and adults), outdoor leadership, campus recreation, activity programming, military recreation, intramural league programming, and adventure recreation.

The minor requires 15 units, all of which must be taken in Recreation, Parks, and Tourism Administration. At least 9 units must be upper division, with at least 9 upper division units taken in residence at Sacramento State.

Minimum Grade Requirement

A grade of "C-" or better is required in all upper division courses applied to the minor.
