**Briefly describe the program proposal (new or change) and provide a justification:**

- 1) Students will no longer be required to take Greek 6a and Greek 6b. Greek 6a/6b has not been offered for more than six years and has become an obstacle for students to complete the Hellenic Studies Minor.
- 2) In place of Greek 6a/6b, students would be required to select either History 101a/101b or History 102a/102b.
- 3) Greek 6a/6b will be identified as electives.
- 4) Art 1a will be removed from the electives because it does not emphasize Greece.
- 5) Phil 192d will be removed from the electives because the course has been de-activated.
- 6) Hist 143b will be removed from the electives because the course does not emphasize the Greeks enough.
- 7) History 104a, History 106, Hist 109b (new course currently in process of approval), Hist 143c, HRS 117, and Phil 125 will be added as electives. These courses were developed since the establishment of the Hellenic Studies Minor and they all have a strong Greek emphasis.
- 8) The number of units required for the Hellenic Studies Minor will be reduced to 21 units as the removal of Greek 6 a/b reduced the number of units for the minor by 2 units. Language courses are 4- units each, while all the other courses are 3-units each. There are the same number of courses required.

Wording is much better on Curriculum Roadmaps where you also use "analyze", "evaluate", "recognize and produce", in the language. Bring that language to the Program Learning Outcomes consistently in all areas where they are mentioned. Change language in Assessment Doc to "Outcome" vs. "objective".
