In order to comply with EO 1071, our previously existing NUFD concentration in the FACS Department was proposed as a stand-alone degree program, "B.S. in Nutrition and Food." This was approved and became effective in fall 2019. As a result of this change, we are seeking to develop Special Problems to NUFD 199 since the existing FACS 199 is no longer relevant. Moreover, the evolution proposal of separating NUFD from the Family and Consumer Sciences was recommended unanimously by the Faculty Senate and approved by the President as of October 2022. As a result of this change, we are proposing a new course, NUFD 199 Special Problems, which is needed in preparation for the upcoming new department, Nutrition, Food & Dietetics (NUFD). NUFD 199 will provide opportunities to NUFD students to gain experience in research and for graduate school and career readiness.
