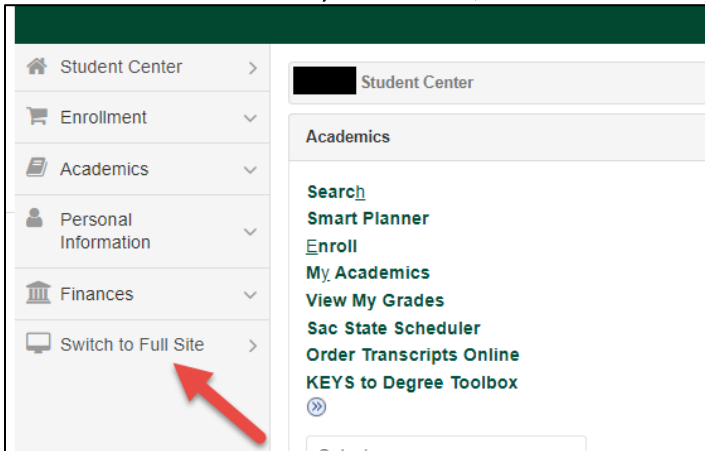


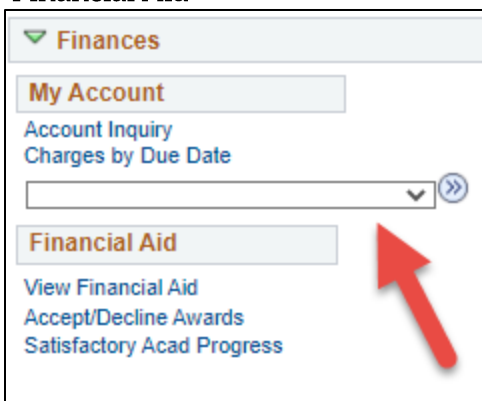
1. From the Sac State main page (csus.edu) click on My Sac State and enter your SacLink username and password to log in.
2. Click on the "Student Center" link.



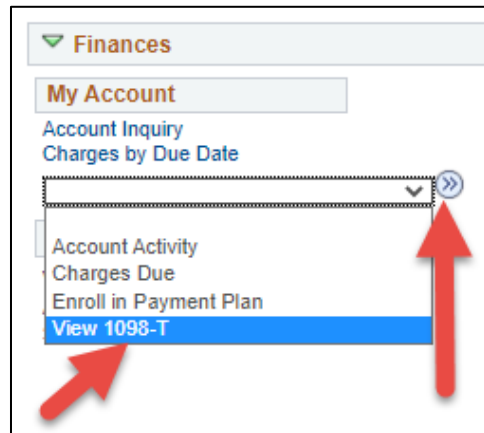
3. On the left-hand side of your screen, click the Switch to Full Site Link
