Sealed proposals will be received in the Procurement and Contract Services Office on **May 23, 2018 at 2:00 p.m.**, in accordance with the bid documents, at which time the proposals will be publicly opened and read. The bid must be submitted on the Bid Proposal Forms provided by the University, completely filled out and sealed in an envelope.

All contractors and all tiers of subcontractors bidding on this project shall register to bid public works projects with the Department of Industrial Relations (DIR), and maintain current this registration pursuant to Labor Code Section 1725.5. A **mandatory** pre-bid conference and site visit will be held on April 25, 2018 at 10:00 a.m. The meeting will be held in River Front Center, Dining Services Offices, Room 111 – Del Rio Suite at 6000 J Street, Sacramento, Ca 95819. **No bidder will be admitted more than ten (10) minutes after the stated start time of the conference.** Bidders are encouraged to arrive early in order to obtain a parking permit, locate a parking space and make it to the location on time. Permits can be purchased at permit machines or by smart phone: <https://paybyphone.com/> (location code 5115 for Sacramento State). **Parking on campus at this time is very limited and it may be necessary to park a long distance from the conference location. Please plan accordingly.**
