3. Presentation on Hornet Leadership Project - Jennifer Lundmark, Professor, Department of Biological Sciences
 - a. The project offers multiple opportunities for students to explore their leadership capacity and engage in socially responsible leadership practice with peers and members of the community. Presently funded by the National Science Foundation, the HLP primarily serves students from the colleges of Natural Sciences & Mathematics and Engineering & Computer Sciences, but would like to expand its offerings to serve all students on the Sacramento State campus.
4. President's Report (Nelsen)
 - a. Proposed tuition increase that would take effect in 2024
 - b. New Sac State President announced – J. Luke Wood
 - c. Concerns about enrollment across the CSUs – overall we are within 1% of where we've been in the past
 - d. Transfer students are down due to low enrollment at community colleges
 - e. Dr. Jeanne Harris-Caldwell hired as the new Senior Associate VP for Student Health, Counseling and Wellness
 - f. Dr. Lisa Cardoza is leaving to become the President at American River College and Sharon Takeda will be the interim VP of University Advancement
 - g. Dr. Ed Mills is leaving to become VP of Strategic Enrollment at Sonoma State University and Dr. Jenni Murphy will be the interim VP of Student Affairs
 - h. Jim Reinhart is retiring and John Melikian will be the new executive director of UEI
 - i. Sac State has a new quarterback this season who looks very promising
 - j. We graduated 2,000 more students this year than five years ago – 9,547 students graduated
5. Advancement Update (Cardoza)
 - a. New CRM coming
 - b. Give Sac State Day raised \$429,500 in just 36 hours

- c. Food Pantry open from 10 am – noon during summer.
 - d. The Children’s Center received a grant to remodel the outside play area
 - e. ASI priority is to work on retention of student employees by looking at how they can best be supported.
8. Board Member Highlight (Drobny for Bugatto)
- a. ASI Food Pantry Update
 - i. 100% of the food at the pantry is now either through donation or through wholesale purchase at the Sacramento Food Bank
 - ii. Nothing is bring purchased at retail prices
 - iii. Now moving onto Phase 2 which will be to expand the food program relationship with the Sacramento Food Bank
 - 1. Continue the shift to a reduction in wholesale food purchases with a greater allocation provided at no cost
 - 2. A van is required to accomplish Phase 2
 - iv. ASI Food Pantry received \$13,300 through Give Sac State Day – a 210% increase from 2022
