MEETING MINUTES

1. Call to Order

- a. Chair Holly Tiche called the meeting to order at 1:36 p.m.
- b. Jonathan Bowman read the Land Acknowledgement
- c. Board member introductions
- d. The agenda for the February 21, 2024 meeting was approved. (Alice Perez/Sonney Chong)
- e. There were no public comments

- f. The Board approved the consent calendar, consisting of the October 12, 2023 board meeting minutes. (Pam Stewart/Tina Treis)
- 2. Dr. Vajra Watson and Tania Nunez gave an update on the Placer Center
- 3. Committee Reports
 - a. Tiche acknowledged Mark Drobny for reaching his halfway goal of \$50M on his way to raising \$100M in planned gifts
 - b. Finance Committee Update (David Lopez)
 - i. Lopez shared information from Sand Hill Global Advisors' presentation to the Finance Committee
 - ii. The board voted to approve the FY 22-23 Financial Statements and Budget to Actuals Comparison as of 12/31/23. (Lopez/Margot Bach)
 - c. Planned Giving Update (Mark Drobny)
 - i. Drobny reviewed the Planned Giving Dashboard document and shared upcoming dates for Estate Planning seminars
 - d. Audit Committee Update (Tina Treis)
 - i. Next meeting will be held on March 11 to approve the 990 forms
 - e. Governance Committee Update (Bernice Bass de Martinez)
 - i. Discussed the plan to pair Governance Committee members with Legacy Board members to keep them engaged
 - ii. Bass de Martinez shared the Board members terms document and pointed out that as of June 30, 2027 there will be seven board members terming off the Board
 - iii. Perez stated that with a group of Board members leaving the board in 2027 it is important for President Wood to weigh in on who should be added to the board so that those relationships can be cultivated
 - iv. Discussed letting Board members join the Board meetings via Zoom if they live out of town/are travelling/ill
 - v. Many Board members agreed that when someone is travelling or feeling ill it is appropriate to attend the meetings virtually but that we encourage inperson participation
 - f. Executive Committee Update (Holly Tiche)
 - i. Tiche reviewed the UFSS Dashboard
- 4. Updates from Retreat Breakout Groups
 - a. Antoinette Vojtech gave an update on the Closing the Equity Gap group's progress
 - i. Plan to leverage support to programs that are currently a priority of the President.
 - ii. Enhance funding toward alumni efforts that increase enrollment, recruitment and retention
 - b. Tina Treis gave an update on the Placer Center/Anchor University group's progress
 - i. Placer Center
 - 1. Worked with Dr. Watson closely on how to best use the funds

- a. Funding to hire a public relations firm to create branding statements seed money \$5K
- b. Funding to sponsor community events seed money to attend events with community members \$10K
- c. Funding for academic clusters for field trips to foster ideas \$10K
- ii. IMPACT Fellowship Program
 - Anchor University and the Career Center at Sac State partner on this
 program to offer paid summer internship opportunities to lowincome students

 - 3. The group voted to fully support the \$25k proposal which included:
 - a. \$9,900 to fund 3 IMPACT Fellows for a 10-week period
 - b. Establish a Faculty Learning Community to train faculty on internship development and become ambassadors \$10k
 - c. Host community receptions in partnership with the Career Center to have community workforce partners interact with faculty and interns to learn about the program and encourage participation \$5k
- c. Jennifer Barber gave an update on the Basic Needs group's progress
 - i. Western Health Advantage donated a transport van to the ASI Food Pantry
 - ii. Direct support for ASI Food Pantry to support implementation of food pantry management software platform and other equipment needs \$10K
 - iii. Marketing assets to support fundraising efforts \$15K
